

CIVIL RIGHTS & THE WAR ON POVERTY

The Economic Opportunity Act of 1964 authorized the formation of local Community Action Agencies as part of the War on Poverty. These agencies are directly regulated by the federal government.

he Salisbury-Rowan Community Action Agency, Inc., one of more than one thousand Community Action Agencies nationwide operating since 1964, continues to serve the community's most vulnerable population and a constant reminder of the monumental moment of President, Lyndon B. Johnson declaring war on poverty and in addition, signing the Voting Rights Act. In commemoration of Black history month, the importance of these causes will be discussed.

The phrase "War on Poverty" was the unofficial name given to the **Economic Opportunity Act**, Johnson's political mandate after he delivered his first State of the Union address. The nation had recently witnessed the assassination of former President Kennedy months before in which Vice President Johnson was sworn into office.

This was also during the heightened era of the civil rights movement for justice and equality. Furthermore, the Civil Rights movement played an active role in the implementation of legislation and initiatives that Johnson proposed. Groups such as the NAACP and Urban League were influential allies to the Johnson administration. Martin Luther King Jr. was one of several Black leaders that met with the president and other key administration officials directly to collaborate efforts to aid victims of poverty-related conditions.

On June 4, 1965 during President Johnson's Commencement Address at Howard University, "To Fulfill These Rights", Johnson expressed the link between the Civil Rights bill and the War on Poverty as well as the limitations of justice and the lack of economic empowerment of black Americans" (Laurent, 2015), "We seek no just legal equity but human ability, not just equality as a right and a theory, but equality as a fact and equality as a result" (Johnson, 1965).

As a result of the policies enacted by the Johnson administration, social activist Bayard Rustin stated that "It seems reasonably clear that the Civil

Rights movement, directly and through the resurgence of the social conscience it kindled, did more to initiate the War on Poverty than any other single force" (1965, 27). His commentary was validated by Johnson's aide Richard Goodwin (Laurent, 2015), who stated that "the Civil Rights revolution demonstrated not only the power and possibility of organized protests, but the unsuspected fragility of resistance to liberating changes." (in Milkis & Mileur, 4). It is therefore acknowledged that the Civil Rights Movement of 1964 was a direct influence on the "War on **Poverty**", and although the war on poverty was intended to improve racial equality issues, the programs created helped lowincome families in general, regardless of social status or ethnicity.

Ester Jones also known as Baby Ester was the original inspiration for the Betty Boop caricature in 1930. Cartoonist Max Fleischer was inspired by Ester's performance as a Jazz musician and her signature baby voice singing the adlib "Boo Oop A Doop." When the animated character became popular, Fleischer and Paramount studio were sued for using Ester's likeness without compensation. Paramount denied the claim and had hired Mae Questel to be the Caucasian face on the character. Paramount lost the lawsuit when earlier footage of Jones was introduced performing the signature Betty Boop persona. Questel continued to enjoy the success of being Betty Boop while Jones remained unsung.

INGREDIENTS

- 1 pound baby potatoes, halved
- 5 tablespoons extra virgin olive oil
- kosher salt and black pepper
- 4 (5-6 ounce) salmon fillets
 1 tablespoon chopped fresh oregano
 1 teaspoon smoked paprika
- 1 tablespoon orange zest, plus 6 orange slices
- 1 tablespoon lemon zest
- 1 pinch crushed red pepper flakes
- 2 small shallots, thinly sliced
- 2 cups baby arugula
- 1 tablespoon toasted sesame seeds

CITRUS AVOCADO SALSA

- 1 avocado, diced
- 1/2 cup fresh cilantro, chopped
- 1/2 cup fresh parsley, chopped
- 3 tablespoons extra virgin olive oil
- juice of 1/2 an orange
- juice of 1/2 a lemon
- 1 pinch flaky sea salt

Directions

1. Preheat oven to 425 degrees F. On a rimmed baking sheet, toss the potatoes with 2 tablespoons olive oil. Season with salt and black pepper. Roast for 20 minutes, or until tender. 2. Place the salmon on a plate and rub with the oregano, paprika, orange zest, lemon zest, crushed red pepper flakes, and a pinch each of salt and pepper. Drizzle with 2 tablespoons olive oil, rubbing the seasonings evenly into each filet.

3. Remove the potatoes from the oven and push them to one side of the pan. Put the salmon on the other side. Arrange the shallots

and orange slices around the salmon. Drizzle over 1 tablespoon olive oil. Return the pan to oven and roast for 10 to 20 minutes more, until the salmon reaches desired doneness.

4. Meanwhile, make the salsa. Combine all ingredients in a bowl and toss to combine.

5. Toss the arugula with the remaining 1 tablespoon olive oil, the sesame seeds, and a pinch of salt.

6. To serve, divide the salmon and potatoes between plates. Spoon the salsa over the salmon. Add a handful of arugula to each plate. Eat and enjoy!
